Results from the survey performed late last year are in. Here are some of the key take-aways from the survey:

- 1. Over 80% believe AACEI can be of benefit to you
- 2. Networking and continuous learning is what attracts you to the monthly section meetings
- 3. It is clear that good speakers who engage the audience and have interesting/relevant/timely topics will provide incentive for good turnouts at the section meetings

March 2011 UpCountry SC Section Dinner Meeting Recap

The Upcountry SC Section meeting was held on March 08, 2011 at Jacob's office. Only 6 members attended this meeting. Our guest speaker was Edward Storer. Mr. Storer is a well-known financial coach and educator for twenty-two years in the Carolinas teaching tax reduction strategies and retirement classes. Edward is the owner and Founder of an Independent Wealth Planning Firm that focuses on Coaching & Planning in the areas of Taxes, Investments, Insurance and Estate (TIIE) plans. His goal in creating Edward Storer & Associates is to have all of the financial specialists working together under one roof.

The 1-1/2 hour presentation was very interesting and engaging. Edward first highlighted that most of us have very little time left to save money for retirement purposes. But it is not too late and we all need to plan, either on our own or with the help of a financial planner. He then pointed out that the Federal Government and IRS have established rules that are geared towards you first saving your money, then getting a piece of it through taxes as you withdraw your money vs. you keeping it tax free. There are 4 investment/tax buckets that are available to the public and everyone needs to understand them in order to create a True Wealth Plan. These buckets are:

- 1. Taxable: Savings and other financial investments that are not tax free or tax deferred, such as CD's. You pay taxes on a yearly basis for the earnings you make from these investments.
- Tax Deferred: Savings that use pre-taxed income and are tax deferred until withdrawn, such as 401K's or IRA's.
- 3. Tax Free: Savings that use taxed income but are tax free when withdrawn, such as Roth IRA
- 4. Tax Free xl: Income that is tax free usually from a special designated trust and estate.

Unfortunately, tax rates are almost certainly increasing in the future; however Ed explained ways to save thousands of dollars by repositioning money from a tax deferred bucket to a tax free bucket.

The second half of the presentation was a discussion on the difference types of investment professionals and the warning signs we should all be aware of when seeking out a financial professional. A broker-dealer is a person or company that is in the business of buying and selling securities – stocks, bonds, mutual funds, and certain other investment products – on behalf of its customers. An investment adviser is an individual or company who is paid for providing advice about securities to their clients. They usually manage investment portfolios and provide financial planning services. Investment advisers are not the same as financial advisers and should not be confused. The term financial adviser is a generic term that usually refers to a broker. Both professions are regulated by the SEC.

Both tax preparers and tax advisors are "tax preparers" and can prepare a tax return, but a tax advisor provides many more services for their clients. A tax preparer offers very limited advice on how to reduce income tax liability, and usually prepares tax returns in one quick appointment. A tax advisor provides personalized strategies to help reduce income taxes for years to come and considers tax implications now and in the future. Tax advisors usually meet twice with clients to ensure lowest tax liability and keeps in contact with his/her clients throughout the year. Edward stressed the importance of fully understanding the difference types of investment professionals available to ensure you receive the service and product that best fits your financial situation. He suggested calling the National Ethics Bureau at 800-282-1831 to obtain background information on financial professionals and also visit the Better Business Bureau to check their ratings and complaint history.
